Notices of Violation (NOV)

For the third quarter of 2014, Sunshine Canyon Landfill received twelve Notices of Violation: July 23rd, July 27th, August 16th, August 26th, August 27th, August 28th, September 11th, September 14th, September 16th, September 25th and September 30th.

Storm Water Controls

There is a comprehensive surface water management system at Sunshine Canyon Landfill that includes perimeter and interior drainage channels, four permanent sedimentation basins and several temporary basins to remove sediment from surface water leaving the site. The site operates under a statewide General Industrial Storm Water Permit. That permit defines the rainy season as Oct-May, and Sunshine Canyon conducts monitoring of runoff water quality during that time in accordance with the site's permit requirements.

Sunshine Canyon Landfill Hotline Report

- Third quarter 2014 received 77 calls, 10 calls were from a SCAQMD inspector reporting complaints to AQMD's hotline, and 6 calls were complaints directly called into the Sunshine Canyon Landfill hotline.

Landfill Gas Monitoring

The latest Rule 1150.1 Quarterly Monitoring Report was submitted in August 2014 for the second quarter of 2014. This report contains the results of the monthly surface emission monitoring (SEM) (instantaneous and integrated), results of the monthly monitoring of the site's perimeter gas probes and other information as required by SCAQMD's Rule 1150.1.

The results of the instantaneous SEM showed the following number of locations exceeding the regulatory threshold of 500 parts per million (ppm) Total Organic Carbon (TOC) for the reporting period: April - 61 locations on 344 grids monitored; May - 55 locations on 350 grids monitored; July - 7 locations on 344 grids monitored. The results of the integrated SEM showed the following number of grids exceeded the regulatory threshold of 25 ppm TOC for the reporting period: April - 9 grids out of the 345 grids monitored; May - 26 grids out of the 350 grids monitored; June - 12 grids out of the 344 grids monitored.

For this reporting period, the locations where the readings exceeded the regulatory threshold were either (1) repaired and passed the 3-day re-check and/or the second 10-day re-check as allowed by Rule 1150.1, or (2) the exceedances were addressed by expansion of the gas collection system by the installation of additional gas extraction wells.

Vegetation

The Vegetation Report for the Second Quarter of 2014 was submitted to the agencies in August 2014. This report details the various vegetation activities that are being conducted on the site. A meeting was held at Sunshine Canyon Landfill on August 12th with agency personnel to discuss the vegetation activities and to tour the coastal sage pilot project mitigation area. Maintenance activities on the City South C trial pilot project continued throughout the third quarter of 2014 and will continue for the remainder of the year. The evaluation of this area continues with quarterly monitoring.

Sunshine Canyon City/County Landfill Waste Acceptance Averages

The site has been operating as a Joint City/County Landfill as of January 2009. Waste acceptance averages for each month of the third quarter of 2014 are shown below. The site is permitted to accept 12,100 tons per day (TPD) maximum daily capacity (M-F).
